2. ALL SALES ARE SUBJECT TO A 10% BUYERS PREMIUM, WHICH IS ADDED TO THE BID PRICE unless otherwise noted in auction brochure and advertising.

3. ALL SALES MUST BE PAID IN FULL ON DAY OF SALE.

4. ALL ITEMS MUST BE REMOVED ON DAY OF SALE.

5. ALL TRANSACTIONS ARE SUBJECT TO FLORIDA SALES TAX UNLESS A COMPLETED AND CURRENT FLORIDA SALES TAX CERTIFICATE OF RESALE IS ON FILE AT THE TIME OF REGISTRATION. NO EXCEPTIONS!

The Buyer, its agents, employees and/or parties acting on its behalf, specifically agree to hold harmless the Auctioneer, its officers, directors, and employees from any injuries or damages arising from any activities associated with this auction, physical or otherwise, including, but not limited to, the removal of auctioned items from the premises. Further, Buyer agrees to indemnify Auctioneer and/or Seller from any claims brought by third parties against Auctioneer arising from or out of the auction that are in any way attributable to any acts or omission on the part of the Buyer.

9. The undersigned, in his/her individual capacity, personally guarantees payment of the gross bid. Failure to do so will result in further options to participate in any auctions.
